

## FROM KC STUDIO'S CO-FOUNDERS



The Wallace Foundation sounded an alarm: "Experienced journalists are being squeezed out ... this gap needs to be filled or the transmission of arts news is likely to weaken demand for the arts. Attracting and engaging new audiences is challenging for arts organizations because, even as the number of arts groups has grown, national rates of participation in the arts have declined, arts education has waned, and competition for ways to spend leisure time has increased." – **The New York Times** 

Kansas City is not immune to this trend: although the arts here are exploding, nearly every media outlet has slashed or discontinued its arts coverage. *KC Studio* seeks to fill the gap by providing high-quality coverage bimonthly. Arts coverage is essential for KC cultural organizations to grow audiences and maintain and increase support.

*KC Studio*, a 501(c)(3) published by The Arts Engagement Foundation of Kansas City, is the metro's leading independent journal of the visual, performing, literary and cinematic arts. Our mission is to build audiences and increase participation in the arts through informed, expert coverage of the region's cultural offerings. Since *KC Studio*'s inception, our print contributors have covered more than 11,000 + arts organizations, galleries and independent artists. *KC Studio* also provides monthly online reviews of theater, classical music and dance performances and visual arts exhibitions, written by specialists in their fields.

75% of our budget comes from earned revenue while 25% from contributed support. Contributed support allows us to provide vital coverage of artists and arts organizations. Coverage is critical for building new audiences and supporters. To further our mission, we are committed to expanding our base of contributed support to allow us to feature more organizations in print and online.

Great cities possess a strong arts and cultural scene, and support of the arts is an essential part of a city's success and community growth. The best way to further stimulate audience development begins with making people aware of our city's many wonderful art and cultural opportunities. That is an essential part of *KC Studio*'s mission, and we strive to fulfill it in a lively, engaging way that gets people excited and involved as participants in and patrons of the arts.

## FROM THE EDITOR

Hello valued KC Studio family and patrons,

KC Studio celebrates our 15th Anniversary in 2023 and coverage of more than 11,000+ artists, organizations, galleries, and museums since 2008!

As we head into our 15th anniversary year, *KC Studio* continues to build on our record of energized and insightful coverage of all sectors of Kansas City's diverse and multitalented arts community.

In the past year alone we have introduced our readers to topics and talents ranging from Gavin Dell and his establishment of a new animation academy in the Crossroads; a lively contingent of up-and-coming Latinx artists who are making their mark in the city's galleries; a series of new, locally produced films, including a mini-documentary on KC's lowrider community and Sandy Woodson's documentary about the "Womontown" community that settled in KC's Longfellow Neighborhood; a heartfelt remembrance in words and images of Jim Leedy, who made an indelible mark on the city as an artist, educator and entrepreneur; and a fascinating account of the Lyric Opera's 1971 performance of "Jesus Christ Superstar."

Our Honors and Artist to Watch profiles encompassed the achievements of singers, sculptors, musicians, painters, actors and photographers. Other stories have covered the activities and contributions of people like veteran KPR folk DJ Bob Williams, Lone Jack-based auctioneer Dirk Soulis and Vietnamese coffee shop founder Jackie Nguyen, who help give the Kansas City cultural scene its unique and vibrant character.

In every issue we advance and review important performances and exhibits from the city's major arts organizations, including Lyric Opera KC, Kansas City Symphony, Kemper Museum of Contemporary Art, Nelson-Atkins Museum of Art, Nerman Museum of Contemporary Art, UMKC Conservatory of Music and Dance, KCRep, the National WWI Museum and Memorial. and the Kansas City Museum. We also keep readers in the know about savvy and ambitious smaller groups like KC VITAs Chamber Choir, and the challenging and stimulating productions emanating from KC's vibrant theater community.

We are fortunate to be able to share the ideas and insights of established columnists, including Julius Karash (Business and the Arts); Steve Paul (See Hear: Rambling around the Arts) and Libby Hanssen (Concert to Come), as well as specialists in their fields such as Harold Smith (African American art and culture), and Emily Spradling (LGBTQ+ cultural issues).

In addition to varied editorial offerings from our roster of seasoned experts, in the past year *KC Studio* published an 8–page sponsored profile on The Volland Store in November 2021. In March 2022, in partnership with The Charlotte Street Foundation, *KC Studio* printed and polybagged a special booklet celebrating the organization's 25th anniversary funded by The Jedel Family Foundation. In 2022 we also welcomed new Arts Consortium members: Theater League, Powell Gardens and Park ICM to our pages, where they tell their own stories.

In the past year, *KC Studio* has also worked to develop a robust online presence through our regular online reviews. In a 12-month span, we've covered 25 visual art exhibitions and 65 theater, dance, and music performances. In 2021 - 2022, *KC Studio* covered 795 artists, organizations, galleries, and museums as well as literary and cinematic endeavors.





## **FINANCIAL INFORMATION**

COVID impacted the entire country with business and venue closures and Kansas City was not immune. While *KC Studio* was able to continue robust editorial coverage on artists and arts organizations and the creative ways they continued to create their art during the pandemic, there was a significant impact on earned revenues on the magazine.

The good news is that revenues are steadily returning to pre-covid levels and that our contributed support has been on the rise. This past fiscal year we hired a talented consultant to assist us in our sales and marketing efforts and develop **new** online and digital offerings important to our long-term vitality.

If you remove the one-time consultant's cost and Lighton International Artist Exchange Program costs, totaling together \$78,545, we would have shown a surplus of \$22,378 for the fiscal year as opposed to a loss of \$114,851 in the middle of the pandemic. We are making strong improvements and we anticipate this will continue into the current fiscal year.




