

FROM KC STUDIO'S CO-FOUNDERS



KC Studio was formed 17 years ago to fill the gap left by a sharp decline in arts journalism in Kansas City and the region. Today, KC Studio is the only source of professional arts journalism for Kansas City audiences, artists and arts organizations.

KC Studio goes beyond covering the mainstream arts and cultural organizations. There is an intentional focus on diversity and inclusion in our coverage. Since 2020, 73% of our feature stories have been on artists from the African American, Hispanic, Asian, and LGBTQ+ communities. If artists are going to make Kansas City their home and continue to make this a thriving arts community, they need to be known. Our features and reviews build audiences and patrons for artists and arts organizations.

KC Studio is published by the Arts Engagement Foundation of Kansas City, a 501(c)(3) dedicated to building audiences and increasing participation in the arts through education and promotion of the region's cultural offerings. **Our board** is as diverse as the artists and arts organizations we cover.

Professional arts journalism is critical to the growth of the arts community. Kansas City arts organizations are struggling to rebuild audiences post COVID-19. Objective reviews and critical arts coverage help arts organizations demonstrate quality, build audiences and secure funding from national arts funders. Arts journalism can increase accessibility to the arts and amplify important works of performing and visual art, including those addressing rising social challenges. These constituents consistently report that *KC Studio* has a dramatic and positive impact on the arts community.

Since the January 2025 launch, *TeenTix KC* has been a smashing success! TeenTix KC is working to build future audience participation in this essential dimension of teens' lives. More than 1,100 teens have downloaded the free pass, allowing them to see performances for just \$5. For many, it's their first time attending an arts venue! https://kc.teentix.org. Read about the details in our annual report.

KC Studio's key accomplishments include providing exposure in our pages to more than 19,7984 arts organizations and individual artists since our inception, driving the arts economy (61% of our readers spend money on arts purchases), covering more than 700 features or over 1,400 mentions of organizations or individual artists. Our recent 2025 survey indicated that 78% of arts audiences make decisions about arts based on our viewer website statistics, launching a comprehensive digital marketing platform to reach our 14,000 subscribers, and establishing KC Studio as the go-to publication for arts information.

Contributed support from our donors has played a significant role in providing general operating support that allows us to pay for writers and photographers to bring the arts alive and enables us to serve arts organizations and artists. *KC Studio*'s operating support is more critical than ever as we have experienced an unprecedented increase in postage and paper costs.

Our hope is that the information provided demonstrates why your annual support is vital for *KC Studio* moving forward. We thank you for your longtime support of our efforts to ensure that Kansas City remains a vibrant arts community.

FROM THE EDITOR



The past year has been one of challenges for arts organizations and artists, following the January installment of a new

administration in Washington opposed to DEI, engine of many non-profits' programming, and various moves to defund the arts, as reported in Robert Trussell's "Defunding the Arts" story in our July/August issue.

But as seen in the 2024-25 issues of KC Studio, Kansas City arts organizations have proven resilient and resourceful in the face of these challenges, thanks in no small part to the determination of their leadership and the generosity of the city's granting agencies, foundations and private philanthropists. Notably, The Nelson-Atkins Museum of Art announced the selection of WEISS/MANFREDI Architecture/Landscape/Urbanism to design a major expansion on the museum's west side, and the University of Missouri announced plans to expand and renovate its performing arts center.

The September/October 2024 issue featured our annual comprehensive roundup of the coming season's music, dance and theater performances and a profusely illustrated section advancing visual arts exhibitions in Kansas City and the region. Kemper Museum of Contemporary Art celebrated its 30th anniversary and Starlight Theatre marked its 75th. Linda Hall Library upped its game with the hiring of its first vice president of exhibitions and project management aimed to more fully engage the public with the library's holdings and activities, as exemplified by its popular "Life Beyond Earth" exhibit examining extraterrestrial life.

Throughout the year, we dug in on our mission of covering Kansas City's vast and diverse exhibitions and performances, including a display of Mexican dolls from the collection of Maria Vasquez Boyd at the National Museum of Toys and Miniatures, the Crystal Bridges Museum's "Knowing the West" exhibition acknowledging "the multiplicity of makers and artists inhabiting the Western milieu," and Sonie Joi Thompson-Ruffin's "Joy is Resistance" exhibit at

The Museum of Kansas City.

Artists are the heartbeat of KC's culture scene, and we cover them all — visual, performing, literary and cinematic — in profiles, features and reviews. Kansas City also benefits from innumerable artist-founded ventures, from musical groups like Te Deum and NAVO, covered by Libby Hanssen in her regular Concert to Come column, to a proliferation of artist-run galleries, chronicled by Pete Dulin in our July/August issue.

Film is in growth mode in the Kansas City area and we keep readers in the know, with annual online coverage of the Kansas City FilmFest International and the Kansas City Underground Film Festival, as well as feature stories including Mel Neet's in-depth look at the work of Kansas-based Native filmmaker Rebekka Schlichting in our January issue.

Literature is another area of focus, including book reviews, local author interviews and periodic thoughtful essays by Robert Stewart, editor emeritus of "New Letters" magazine.

If it's beautiful, provocative or timely, you'll likely find it in our Artist Pages section, which last year featured illustrated accounts of young KC designer Whitney Manney's costumes for the White Theatre's production of "Hairspray," a curated selection of pages from a new book by Korean-born artist Ke-Sook Lee and photographer Jim Barcus' dazzling closeups of orchids featured in Powell Gardens' Orchid Delirium display.

The past season was one of firsts, including a wildlife exhibit at The Nelson-Atkins Museum of Art and the Lyric Opera's presentation of "Cruzar la Cara de la Luna," the first-ever mariachi opera. And there were many leadership changes: The Kansas City Art Institute named Dr. Peggy Shannon as its new president, Jessica S. Hong joined Kemper Museum of Contemporary Art as chief curator and KCRep announced Jeremy Dewey as its new executive director. The Unicorn Theatre welcomed Ernie Nolan as its new artistic director following the visionary tenure of Cynthia Levin. Mark

Adams was named the sixth director of the Harry S. Truman Presidential Library and Museum.

And sadly, we said goodbye to longtime Kansas City artist luminaries Zigmunds Priede, Philomene Bennett, Gerry Trilling, James Brinsfield and Ke-Sook Lee.

In print and online, we advance and review important performances and exhibits from the city's major arts organizations, including Lyric Opera KC, Kansas City Symphony, Kemper Museum of Contemporary Art, The Nelson-Atkins Museum of Art, Nerman Museum of Contemporary Art, American Jazz Museum, UMKC Conservatory of Music and Dance, KCRep, the National WWI Museum and Memorial, The Truman Library and Museum, The Museum of Kansas City and Union Station.

We continue to share the ideas and insights of established columnists, including Steve Paul (See Hear: Rambling Around the Arts) and Libby Hanssen (Concert to Come), as well as specialists in their fields such as Harold Smith (African American art and culture) and Emily Spradling (LGBTQ+ cultural issues). With the retirement of Julius Karash from his Business and the Arts column, and the completion of Natasha Ria El-Scari's The Artist's World series, veteran artist and writer José Faus agreed to join our roster of columnists and will share his Cultural Meanders around the city.

In the past year, KC Studio has continued to develop a robust online presence through our regular online reviews. In a 12-month span, we covered 26 visual art exhibitions and 40 theater, dance and music performances at venues ranging from the Kauffman Center to the Consulate of Mexico to the Spinning Tree Theatre in Overland Park. Veteran film critic Mel Neet has kept readers abreast of the KC film scene with timely online advances of the KC Fringe Festival's film weekend, the Kansas City FilmFest International and the Kansas City Underground Film Festival. — Alice Thorson, Editor, KC Studio


ONLINE PRESENCE

Readers can find new reviews every week of the best in visual arts, theater, Performing and Classical Music and Dance on *KC Studio*'s website. All organizations are notified about the review to share on their website and with constituents the day of release. These reviews are shared on our Facebook, Instagram, X (formerly know as Twitter), LinkedIn, and in our biweekly review's newsletter. From the opening season September 2024 through August 2025, *KC Studio* has reviewed 49 performing/Classical Music & Dance organizations performances and 26 visual art exhibitions.














TeenTix KC



TeenTix KC builds a bright future for our region by empowering young people to take an active role in shaping their arts community as audience members, critics, influencers, advocates, patrons, and leaders.

An initiative of KC Studio, TeenTix KC launched in January, 2025. Any teen, 13-19 years old, can download a free pass allowing them to buy \$5 tickets to any participating arts venue in KC. The **1,100 teens** who have already signed up can explore arts journalism by applying for the *Press Corps*, where they write reviews and craft social media posts supporting the arts community.

FINANCIAL INFORMATION

Financial Commentary, September 2025

Our priority this year has been restoring **KC Studio** to profitability, while our other initiatives: the **Lighton Fund** and **Teen Tix** continue to remain stable.

We faced early challenges but a strategic decision to re-engage a proven sales consultant has already revitalized revenues and staff morale. Though this unbudgeted investment, along with moving costs, contributed to a 2025 loss, we are confident it has set the stage for strong, sustained growth in FY2026.

Momentum is already clear:

- September/October issue 2025 was the highest earned revenue performance since 2017.
- Launching our new podcast: Artful Connections Along the Streetcar brings us into a new communications arena, furthers our mission and was fully funded by two major sponsors-Arvest Bank and Tivol.
- Expanded 6× advertising contracts and consortium packages, securing significant commitments with partners like Arvest Bank, Kemper Museum, Starlight Theatre, the Lyric Opera, The Rabbit hOle and more.
- Secured upgraded commitments from Kansas City Public Library and Kauffman Center.
- Introduced high-margin print innovations (glued-in inserts) and nearly sold out new monthly dedicated emails.

Teen Tix is quickly becoming self-sustaining, with over **1,000 teens enrolled in just six months.** This program is already helping build the next generation of arts audiences.

Looking ahead:

Our goal for 2026 is a \$50,000 net income, requiring significant amount of new revenue. Encouragingly, nearly \$100,000 in new revenue is already secured and we are only our third month of our fiscal year.

There will be attrition, always the case, but our revenue goals appear achievable given our current trajectory.

2025 was an investment year. 2026 will be our turnaround year — and we're already seeing the results.


